- Develop an overall communication/involvement campaign to let residents and visitors know how they can become involved to protect The New.

- Provide promotional and logistical support for organizations/groups that organize/sponsor in-river cleanup events during the month of August.
- Provide promotional materials encouraging kayakers, tubers, canoers and floaters to pick up debris and trash during their trips on The New and deposit it in the provided containers at designated takeout locations.

**NOW, THEREFORE, BE IT RESOLVED** that the Ashe County Board of Commissioners hereby proclaims August as Clean River Month and encourages all residents and businesses to do their part in helping to keep the New River clean.
