# **County Commission**

#### WORK SESSION - 8:30 AM

Chairman Sands called the Work Session to order at 8:30 a.m. at the Ashe County Courthouse.

Chairman Sands told the Board that Commissioner Gary Roark resigned his seat on the Board effective at midnight on November 30, 2017 after serving as a commissioner for seven years. Chairman Sands then read General Statute guidelines pertaining to filling a vacancy on the Board of Commissioners.

Since this is the first meeting in December, the election of chairman and vice chairman is on the agenda. Chairman Sands explained that since there are now four members on the Board, if there is a tie vote to fill the position of chairman, the current chair will continue until the fifth commissioner is voted in.

Chairman Sands then reviewed items on the agenda.

County Attorney John Kilby provided information on the request for a loan subordination. A citizen is requesting to borrow money from a lender that requires their deed of trust to be in first position. This will require the County to subordinate their deed of trust to second position. County Attorney Kilby sees no harm in the subordination and there will be no liability to the County on any condition.

County Attorney Kilby provided information regarding the scheduled Executive Session. Discussion will be held regarding recommendations made by counsel for the County. If the County decides to appeal the decision made by the Superior Court Judge, several actions will need to be made in Open Session.

No further comments were made and the Work Session was closed.

County Manager Sam Yearick opened the meeting and called for nominations for the position of chairman of the Board of Commissioners. The motion failed 2 - 0, with Commissioners Rhodes and Sands voting in opposition. County Manager Yearick asked if there were any other nominations. Commissioner Rhodes made a motion to close nominations. Commissioner Rose

seconded the motion. The motion passed with unanimous approval.

County Attorney Kilby explained that with the current tie vote, the current chairman, William Sands, will remain in the position until a fifth board member is present to break the tie. The position of vice chairman will be voted on at the same time as the vote is taken for chairman.

### VI. Public Comment

Chairman Sands opened the floor for public comment.

Donald Nelson spoke regarding events that have happened in County government within the last year, specifically the recent resignation of Commissioner Gary Roark, Sheriff Buchanan's appointment to office, and events that have taken place since that time. Mr. Nelson stated that he believes inappropriate decisions have been made and that the Board should get better advice before making decisions.

Rose Price spoke about standing for your rights. She stated that people make good and bad choices and that there are resulting consequences for each. She is concerned for the effect the conflict is having on children in the County. Ms. Price would like to see the Board of Commissioners united and working together.

Larry Ward thanked the two commissioners that reached out to him for input regarding the resignation of Commissioner Roark. He made a request for the Republican Executive Committee to be allowed to provide input on a replacement. He asked the Board to give the committee time to provide input. He also spoke to comments made by Rose Price. He stated that costs are sometimes too high for decisions made. Mr. Ward stated appreciation for the service that Board members provide. He also thanked County Manager Sam Yearick and Animal Control Director Joe Testerman.

County Attorney John Kilby provided an explanation of the request for the Community Development Block Grant (CDBG) loan subordination. CDBG loans are used to upgrade water and septic systems for low income residents. The loan in question was initiated approximately three years ago and loan requirements have been fully complied with. The citizen is requesting to borrow money and the lender will loan the funds if the County will subordinate the deed of trust for the CDBG loan. The lender's deed of trust will move to first position thus moving the County's deed of trust to second position. Attorney Kilby explained that the County has never had to foreclose on a loan of this nature. Many times the County takes the second position at the beginning of the loan. Also the County has no obligation to the lender. Commissioner Rhodes made a motion to approve the request for a loan subordination. Commissioner Rose seconded the motion. The motion passed with unanimous approval.
