V. Public Comment

Chairman McNeil opened the floor for public comment at 9:03 AM.

Ashe Medic, Ryan Kissell, Blowing Rock, NC took the podium and stated he would like to stress that they, paramedics in this county, who serve 24/7, through holidays, day, night, shine, sleet, snow and rain, were discouraged from coming here to speak to commissioners today. He said they were told not to wear their uniforms. He stated he was here with his beautiful wife and his six month old daughter and that he was also here with his fellow coworkers. He said "I have been a paramedic here in the High country since 2011 around 2017 I transferred from Watauga County to Ashe County, since then I have served this county as a paramedic, I have done everything in my ability to serve this community with professionalism and courtesy, despite any personal or professional challenges put before me. The paramedics in Ashe County are the best I have ever worked with he stated. He said I am proud to call them my friends, I'm proud to call them my family. I served my country working for the Department of defense, I was a civilian specialist that was deployed to the war in Iraq in 2008, I served with Polish, Mongolian, Ukrainian and US Army special forces. He stated that the jacket he was wearing today was his combat jacket. He said it had blood on it, sweat in it and dirt. He stated that it was a symbol for free speech, democracy and liberty. He said this jacket and the flag that adorns it is a shield against intimidation, against tyranny, it's American, it's democracy. He thanked the Board for the opportunity to speak and for providing forum for the public, for free speech, we have a voice, we should be able to speak without intimidation or fear of losing our job. it's our God-given right as Americans.

Cody Darnell, West Jefferson took the podium. Cody is also a Paramedic with Ashe Medics. He read the following prepared statement.

Good morning, commissioners, it is a pleasure to be able to speak before you today. I stand before you as Cody Darnell, Ashe County Native, concerned citizen, and proud Professional Paramedic of 10 years. Nearly my entire EMS career, whether professional or volunteer, has been served here in Ashe County under employment of Ashe Medics. I am beyond honored to care for my fellow man and I hold our position as tax funded public servants in the highest regards. Due to this regard, I am here to speak factually, my lived experience truth, about what is trying to transpire at your contracted EMS service, Ashe Medics.

On May 7th while off duty, I was reading our company's messaging app called breakroom, that a possible merger was to take place between Priority on Demand and the Medics Company, owned by Craig Sullivan. No exclusive details were given, and vague answers were common.

On Tuesday May 14th I arrived at work ready to perform daily operations when the staff was made aware via our breakroom app, and in person that the decision to move forward with Priority on Demand was made. We were given an approximate 30-minute briefing and were told a "Town Hall" meeting with Priority on Demand was to take place via Zoom in our conference room. Priority on Demand sent two in person representatives and the Zoom meeting was presided virtually by Priorities Regional HR Business Partner and their Regional Talent Acquisition Manager. All parties from Priority were either out of state or hours away from Ashe County. During this meeting it was revealed that Priority does not have employees, they have companies, and that many benefits would change including, down grade of medical insurance, removal of 401k match, loss of Aflac, and reduction of PTO. The expected merge date of Ashe Medics and Priority on Demand was to be June 1st. As to be expected this caused significant undue stress for the employees and their families they provide for.

For those of you that do not know I have a preexisting liver condition I was born with called Wilson's Disease. This disease prevents my body from eliminating excess copper and the built-up copper, if not treated, will eventually lead to permanent liver damage, cirrhosis, kidney damage, Parkinson's type symptoms, and death, resulting from multiple organ system failure. Unfortunately, my sister shared this same disease and by the time medical experts knew, it was too late. She passed April 20th, 2005, at 17 years old, in a hospital bed at Carolinas Medical Center. I tell you this not to gain sympathy but to rather state that due to advances in medical care I have nearly doubled her age in years. I have married the love of my life, am privileged to father 2 beautiful children, and am expected to live a full life. All due to 4 pills, taken daily. Unfortunately, like many of my fellow 18 million Americans, who struggle to afford medications, this medication is impossible to afford without quality health insurance. At 19 years old I was no longer eligible for my late mother's insurance she was provided through disability caused by stroke. I had to enter the full-time work force to be able to afford my life altering medications, always checking employee provided health insurance to assure myself, I was covered.

Continuing May 14th after finishing ambulance calls and completing patient care records, I sat down in my room and began yet another search to see if I was covered. Referring to the benefits book Priority gave each employee I learned our insurance provider will now be Cigna and that our prescription drug plan will have 4 tiers of covered medications. After calling Cigna's customer service line they told me that the drug plan Priority provided was outsourced through express scripts. Cigna's representative advised me to call express scripts to see if my medication was covered. Speaking with express scripts, I found it strange that the customer service representative was not familiar with Priority on Demand and that they cannot tell me any information without having an enrollment number or plan ID. Not wanting to give up, I went back to Cigna's website and searched numerous PDF files to see if my medication was covered or what tier they classify it as. To my disappointment I discovered that my medication is a Tier 5, and as previously

stated our plan offered by Priority only covers up to tier 4. Reality set in my medication is not covered by Priority on Demands health insurance and their coverage starts June 1st. I had approximately 15 days to figure something out.

The following Day on May 15th my day off, our companies messaging app was a buzz with questions, concerns, doubts, pros, cons, and everything in between regarding the merger. Claims were made that PTO will be fixed, Aflac will be fixed, 401k will be fixed yet no mention of improved or similar health insurance. Also, to my knowledge no staff has received any of these claims in writing. To confirm my findings, as instructed by Priority, I called their Regional HR Business Partner. I explained the situation and reported my urgent need to make sure my medication is covered. She advised me to write her an email and that she will send it up the ladder to someone who can help. I have yet to receive a response.

By May 16th we were advised that the rest of the Priorities Town Hall meetings were cancelled and the merger between the companies was on hold. Later that day I was relieved to hear the current Health Insurance with Ashe Medics was extended through June buying me more.

Commissioners, my simple questions are these. If this merger was in the best interest of us as employees and prehospital providers, why were we left out and left behind with only two weeks' notice of this merger taking place? How can something this significant be decided without county oversite?

I stand here on my day off as Cody Darnell, Ashe County Native, concerned citizen, and proud Professional Paramedic of 10 years. Make no mistake, I WANT TO WORK AS A PARAMEDIC IN THE COMMUNITY I WAS BORN AND LIVE IN. Commissioners, with a heavy heart and a great burden please hear this. If this merger takes place and my medication is not covered, I will be forced to leave my paramedic position with Ashe Medics, my hands will be tied. You will gain an out of state for profit company, and you will lose a native son who loves his role in EMS. Thank You.

Seeing no other movement from the citizens in attendance, Chairman McNeill closed the floor for public comment at 9:13 am.

IX. Executive Session

Commissioner Greene made the motion to enter into Executive Session at 10:15 am. Vice Chairman Powers seconded the motion. The motion passed with unanimous approval. The Board returned from Executive Session at 10:40 am. Patty Gambill, Emergency Management Coordinator joined the meeting. Craig Sullivan, the regional EMS director who oversees operations in four counties, including Watauga was also present and asked to address the issues brought to the Board during the public comment portion of today's meeting. Chairman McNeill expressed displeasure of the events leading up to today, noting that commissioners only learned about it after community members began calling with questions and reading about it in the Watauga Democrat. Chairman McNeill also stated that this conversation should have started a year ago. Commissioner Killen read a portion of the county's current EMS contract that requires board approval for any transfer or subcontracting of services, telling Craig Sullivan that there should have told him that he would have to come to the Board first. Board members were also displeased with reports that employees were instructed not to attend the Commissioners meeting today. Mr. Sullivan confirmed the merger is no longer moving forward and promised there would be no retaliation against employees who spoke out. He also said current health benefits would remain in place for now. Mr. Sullivan stated that EMS staff received some misinformation, and that it was his fault and he apologized. Commissioners acknowledged his apology, but also expressed concern about damaged trust and called for better communication in the future. With five years remaining on Ashe County's EMS contract, commissioners said they would like to see it through.

Chairman McNeill stated that the County spends almost 2 million dollars in taxpayer dollars every year and that he thought that should buy the County some goodwill for you to come to talk to us about it."
