*Jennifer talked about how October was full of postponements and cancellations, Volunteer and needs hotlines were set up at Family Central, they attended new Christmas Tree Center at Upper Mountain Research Station, they worked with DSS & Partnership for Children to plan for Christmas, attended St Jude Family Fun Day event*

*Bi-monthly CRC Meetings were held at the Agricultural office. She stated that they worked with Ashe County Childrens Christmas Project and worked with the Partnership for Children to coordinate the Tinsel Toys event sponsored by the Richard Petty Foundation. Volunteers unloaded three airplanes of items for children for Christmas, each child received two gifts, a bicycle, and a helmet and helped with the Sheriffs Office Christmas event. Jennifer also said that it's time to start planning for the Ashe County Volunteer Awards, Volunteer week is observed the week of April 20-26. This event is usually held around April 17th, but there are concerns about staff availability and individuals traveling. An alternate date is being discussed, possibly the first week in May. She stated that they usually receive 450 nominations, but last year around 750 were received. She discussed the possibility of a floating event on a Saturday in the courthouse parking lot. But the Board determined the event would be held May 1st at Ashe County High School, either in the gym or auditorium. Jennifer stated that she is going to send out invitations, get RSVPs back and then come back to the Board for a budget request.*

**PRES 25-3** 9:10 AM - John Pence, Keep Ashe Beautiful - Clean River Proclamation

*John Pence requested that the Board sign a resolution declaring August as "Clean River Month". Vice Chairman Powers made the motion to adopt the Clean River Month Resolution. Commissioner Eldreth seconded the motion. The motion passed with unanimous approval. John highlighted that Keep Ashe Beautiful is planning several river cleanups. The Spring Sweep event is scheduled for Saturday, April 5th. John emphasized the need for many volunteers and a lot of time for these efforts. He noted that the resolution aims to raise awareness of the issues faced by the New River. Keep Ashe Beautiful is planning to construct and place kiosks along the New River during August. These kiosks will hold river cleanup bags for people to use while going down the river. People can take a bag from the kiosk and pick up trash as they travel down the river. This initiative aims to instill the mindset that every month should be "Clean River Month." Keep Ashe Beautiful will coordinate all activities, build and place bag stations/kiosks, acquire and refill bags, provide promotional information to stakeholders, assist with debris disposal, and remove bag stations at the end of August if the outfitters do not want them to remain. Vice Chairman Powers stated that the quote for waterway cleanup was \$115 million. The County is in discussions with the Army Corps of Engineers regarding waterway cleanup efforts.*

*Adam Stumb, County Manager presented to the Board the State and Local Cyber Security Grant Program (SLCGP) & Budget Amendment. He stated that this Cyber Security Grant will support IT in providing training, equipment and software to assist with on going cyber threats via email like phishing and other fraud. After some discussion Vice Chairman Powers made the motion to accept the grant and approve the budget amendment for the grant. Commissioner Killen seconded the motion. *Employee Safety – Vice Chairman Jerry Powers - Jerry expressed concerns about employee safety, especially for convenience center attendants. The Board concurred, recognizing the importance of providing training to clarify expectations and determine appropriate moments to disengage. Emphasizing the priority of safety, Commissioner Greene pointed out that heightened incidents should be reported and assured that employees would be protected from any repercussions. In response, Human Resources will investigate conflict resolution training options to better equip employees in managing potential conflicts.*
