Appalachian Regional Library Board Meeting Thursday, July 15, 2021 Approved September 16, 2021

1. Call to Order

The Appalachian Regional Library Board met in a regularly scheduled session on July 15, 2021 at the Ashe County Public Library. Chairman Doug Butler called the meeting to order at 1:00 p.m. Board members present were Bill Davis Jr, Ala Sue Moretz, Beth Tharrington, Jan Noffsinger, Becky Ball, Kyle Hall, and Margaret Love.

Others in attendance: Jane Blackburn, Director of Libraries; Nicole de Bruijn, Interim Wilkes County Librarian; Suzanne Moore, outgoing Ashe County Librarian; Randy, Watauga County Circulation Manager; Tammy Holston, Finance Manager; and Laura McPherson, Interim Ashe County Librarian.

Absent with notice: JoAnn Crawley, Sandra Basel, and Roberta Jackson.

2. Additions/Deletions and Approval of the Agenda

Margaret Love moved to approve the agenda, Ala Sue Moretz seconded, and the agenda was approved.

3. Approval of the May 20, 2021 Meeting Minutes

Becky Ball moved to approve the minutes as corrected, Beth Tharrington seconded, and the motion carried.

4. Correspondence and Communication

An Ashe Post & Times editorial and article were mentioned.

5. Report of the Library Director and County Librarians

Written reports were included in the Board's mailed packets and are attached.

6. Unfinished Business: None

7. Reports of Standing Committees

Budget and Finance

•20-21 Final Budget Revisions : Tammy reviewed the revisions.

•21- 22 Local Budget Revisions (to include small pay increases for Watauga staff since Watauga County's appropriation was less than requested, and to include bonuses for Ashe and Wilkes staff from unused 20-21 personnel funds since those counties' appropriations remained flat): Jane and Tammy reviewed the required revisions and the explanation of the bonuses.

Bill Davis recommended approving both items and all voted in favor.

Governance

Kyle reviewed changes to the personal policy. One new section C – was included to
outline work from home, and another new section D about working over 40 hours per
week. There was also a revision about time for meals and breaks. Section 18 in Article
VI Fringe Benefits was amended to note that if a Class 1 employee is not scheduled to
work on a paid holiday, they may take another day off in the same pay period. Lastly, a
revision in the User Code of Conduct about allowing weapons in the library only when
specifically allowed by local county ordinance.

Ala Sue recommended a slight change to a section heading. With that change, Kyle recommended approval of the revisions, Bill Davis seconded, and the motion carried.

Personnel

• A new job description was explained by Jane: Adult Services and Digital Specialist. Motion was made by Bill Davis to adopt the new job description and Becky Ball seconded. All were in favor.

8. New Business

- Bill Davis moved to approve the appointment of Suzanne Moore as Wilkes County Librarian, Beth Tharrington seconded, and the motion passed.
- Kyle Hall moved to approve the new Traphill lease amount of \$700 per month, Becky Ball seconded, and the motion passed.
- Jane reported that the easing of COVID restrictions have begun and libraries are working their way back to normal. We will keep an eye on CDC recommendations as there could be a return of precautions with spread of the Delta variant.
- Jane presented, and the board discussed, the idea of keeping the current officers for the next year, and extending the term for any whose term is up, since the disposition of the Wilkes County Public Library with regard to the region is in question for the time being. Kyle pointed to the Regional By-Laws, which state that "All board members shall serve until their successors have been appointed" and that officers shall continue in office "until their successors are duly elected and assume office." In taking no action to elect new officers, the current officers will continue in their roles: Doug Butler as Board Chair, Ala Sue Moretz as Vice Chair, and Becky Ball as secretary.
