County Manager Adam Stumb shared his appreciation for the Boards hard work on this year's budget and extended that appreciation to all department heads as well. One unfinished item was then mentioned by the County Manager as to the incomplete appropriations for the Fire Departments & ARP money due to it not being addressed in the 2022-2023 Budget. He stated that the money was here and that the board could make those decisions during the 7/18/2022 BOC meeting.

Chairman McNeill opened the Public Hearing at 9:05 am and asked if there were any board members that had a comment on the proposed budget He then also asked for public comments. Commissioner Powers then raised a concern about the addition of the Fire Department & ARP money appropriations that are going to be placed in the budget. At that time Chairman McNeill closed the floor for public comments and proceeded to close the Public Hearing on the Proposed Fiscal Year 2022-2023 County Budget at 9:07 am. Finance Officer Sandy Long presented the following budget amendments for the Board's approval at 9:09 am.

Budget Amendments

June 20, 2022

General Fund:

To reduce the department of Corrections by \$55,000 from \$2,552,139 to \$2,497,139.

To increase the department of Law Enforcement from \$3,516,813 to \$3,571,813 with \$55,000 from the department of Corrections for fuel and operational expenditures.

To move \$1,571,000 in the department of Fund Transfers from the Capital Projects fund – Schools line item to the Capital Projects Fund – County line item.

To increase the department of Fund Transfers from \$4,181,723 to \$4,437,098 by increasing Article 40 Sales Tax revenues by \$100,000 and Article 42 Sales Tax revenues by \$155,375 to meet General Statute requirements.

Capital Projects Fund – County:

To increase appropriation for the Capital Projects Fund – County by \$1,571,000 from \$9,015,475 to \$10,586,475.

Capital Projects Fund - Schools:

To reduce the appropriation for the Capital Projects Fund – Schools by \$1,571,000 from \$5,994,851 to \$4,423,851.

To increase the appropriation for the Capital Projects Fund – Schools from \$4,423,851 to\$4,679,226; this increase to be made with a transfer of \$255,375 from the General Fund with Article 40 and Article 42 sales tax revenues as required.

Deeds of Trust Special Revenue Fund:

To increase the budgeted revenues and expenditures of the Deeds of Trust Special Revenue Fund from \$350,000 to \$370,000 with Register of Deeds revenues in the amount of \$20,000 for Deeds of Trust fees collected by the Register of Deeds office which are remitted to the NC Department of Revenue on a monthly basis. This fund is created for audit purposes as required in General Accounting Standards Board (GASB) statement #84 and/or #97.

Commissioner Olive made a motion to approve the budget amendment as presented. Vice Chairman Sands seconded the motion. The motion was passed with unanimous approval.

New Owner Occupied Hanger 22-110

Mr. Bregger proposed the construction of a new aircraft hanger at KGEV. The hanger is intended to be located in the northwest annex of the airport. As presented the hanger will comply with Ashe County building codes, FAA setback requirements, and the parameters established by the Advisory Board for new & rebuilt hangers. The hanger will be designed and constructed by experienced builders in line with a zip-code-based parameter set. The final plan will be evaluated for complete compliance when available. This hanger is intended to be used by an Airman's Medical Examiner to conduct pilot's physicals. The hanger is also intended to be used during some part of the year as an aircraft repair facility. The owner occupant also wishes to install a dedicated septic system as part of the lease. Final lease parameters remain open until the Health Department approves the installation and finalizes placement requirements. The owner would like to start construction this spring or early summer.
