At _:_ PM on October _ _, 2022, the County Manager shall open the sealed bids in the Ashe County Administration Office, 150 Government Cir, Suite 2500, Jefferson, NC 28640, and the highest qualifying bid will become the offer. If there is more than one bid in the highest amount, the first such bid received will become the offer. Seller reserves the right to refuse any and all bids. The successful bidder will be notified. A qualifying bid must be accompanied by a deposit in the amount of five percent (5%) of the bid; the deposit may be made in cash, cashier's check, or certified check made payable to Ashe County. The County will return the deposit on any bid not accepted. The County will return the deposit of the final high bidder at closing. The buyer must pay cash at closing. The Board of Commissioners must approve the final high offer before the sale is closed, which it will do within 30 days. The County reserves the right to withdraw the property from sale at any time before the final high bid is accepted and the right to reject at any time all bids. A \$5,000.00 performance deposit may be required at closing that will be held in a non-interest-bearing account. This performance deposit shall not limit the buyer's liability.
