Jordan Sellers with Blue Ridge Conservancy presented to the Board a request for the county to commit to contributing \$90,000 towards Paddy Mountain Park project. This is in conjunction with the Town of West Jefferson agreeing to commit the same amount, they will meet tonight on approving their \$90,000 contribution. Jordan said that the total cost of the trail/park was \$680,000. They have applied for a Parks & Rec Trust Fund Grant totaling \$500,000. The contributions from the Town & the County will bridge the gap for the total cost of the project. More discussion was held on work to be done & what the money will be spent on such as parking signage, retaining walls, storm water retention, soil conservation & paving of the parking area with two handicap spaces. Contingent on the Town of West Jefferson approving their \$90,000 at their meeting tonight Commissioner Eldreth made the motion to approve the \$90,000 contribution. Adam Stumb, Ashe County Manager presented to the Board an Addendum to Parks and Rec Plan for Paddy Mountain. The Town of West Jefferson is partnering with Ashe County and Blue Ridge Conservancy (BRC) to create Paddy Mountain Park. Paddy Mountain Park will be the first northern trailhead of the Northern Peaks State Trail (NPST). The Paddy Mountain Trails will eventually connect the NPST from Three Top Mountain to downtown West Jefferson, with plans to continue east towards Mount Jefferson State Natural Area. The Paddy Mountain Park will be the first of its kind for West Jefferson and will provide residents of West Jefferson an opportunity to connect with nature from downtown business and residential neighborhoods. This project will be a partnership between the Town of West Jefferson, Ashe County and BRC to provide accessible hiking trails in West Jefferson.
