#### Ashe County CDBG Grant #02-D-2678 Closeout Hearing September 19, 2016

The purpose of this public hearing is to give the opportunity for citizen input concerning the closeout of the Ashe County CDBG Commerce Fellows grant. The County was awarded \$27,476.04 in CDBG funds July 2015. The program provided training to County and Municipal staff through the UNC School of Government to assist low- and moderate-income citizens in Ashe County by increasing capacity building.

The program funded eight (8) seats in five (5) different trainings through the UNC-School of Government. Ashe County, being the applicant, was encouraged to invite interested individuals within the three municipalities to also attend the trainings. The following trainings were offered through the program:

- 1. July 27-30, 2015 Basic Economic Development attendee: Cathy Barr, Ashe County;
- 2. September 16-17, 2015 Developmental Finance Toolbox attendees: Brantley Price, West Jefferson and Cathy Barr, Ashe County;
- 3. September 21-25, 2015 Effective Supervisory Management attendees: Cathy Barr and Jeff Cornett, Ashe County;
- 4. September 2015 May 2016 Municipal and County Administration attendee: Adam Stumb, Ashe County;
- 5. March 15-17, 2016 & April 12-14, 2016 Community Development Academy attendees: Adam Stumb, Ashe County and Wesley Barker, West Jefferson.

The program not only funded the tuition/fees to attend the trainings, but included accommodations, meals, and travel as well as grant preparation and administration.

The cost to the UNC-School of Government for trainings and accommodations was \$20,000 of the grant. Out of the remaining \$7,476.04 \$1,107.50 was expended on meals and travel and \$2,500 on the grant preparation and administration. There is \$3,958.54 remaining in the project which will be deobligated (or returned to the NC Department of Commerce) to be used for other CDBG funded projects.
