MEMO TO: Ashe County Board of Commissioners

RE: Asset Forfeiture Funds

I am requesting that \$10,000.00 (Ten Thousand Dollars) be transferred from Asset Forfeiture Funds into the training line item in the Sheriff's Office Law Enforcement budget for the fiscal year ending June 2017.

Asset Forfeiture money is received from the US department of Treasury and NC Department of Revenue, due to narcotics investigations and controlled substance tax. It is my understanding that these funds can be used to supplement specific line items within our department's budget. Those line items include training (travel, registration fees, reimbursement and meals) and personal protective equipment (vehicles, ammunition, firearms).

During the last several weeks we have identified the need for additional training and equipment. That training will specifically assist our personnel in travel, meals and registration expenses associated with investigations and management courses. Through our recent transition period we have retained new personnel and reallocated other personnel to new positions. Those personnel changes will require the proper training, including less lethal training, to reduce liability to the Sheriff's Office and to Ashe County.

The regulations governing asset forfeiture money specify how these funds can be allocated at the Sheriff's discretion.

Jessica,

1. I moved the funds in the Communications budget that you asked me to move.

They have to get with Ann Clark and get on the Commissioner's Board meeting agenda and get them to approve a budget amendment before any of that money can be moved and spent. Will you please remind them that they must do that part first; and that the purchase order cutoff for this fiscal year has already passed so they need to wait until after July 1st to request to spend those funds and to do the budget amendment anyway.
