Dear Ashe County Board of Commissioners,

This letter will serve as a Letter of Intent (LOI). Thank you for considering Vixster LLC to be a registered commercial waste hauler in Ashe County. We look forward to servicing all Ashe County Residents needing rural waste collection. The following information includes the items discussed between Vixster – Zak Ammar, and the Ashe County Board of Commissioners:

- Vixster to provide weekly and/or bi-weekly trash & recycling collection for residents of Ashe County whom need the service.
- Vixster requests that Ashe County waive the residential dumping fees for Vixster. If waived, then Vixster will agree to:
  - Be an exclusive residential waste collection provider. This includes commercial residential, which is residential homes managed by a third party.
  - Vixster will provide confidential quarterly customer address lists of all Ashe County customers.
- Vixster to incur all dumping fees associated with one-time miscellaneous waste removal at standard Ashe County landfill rates.
- Vixster to use the Ashe County landfill for all dumping.
- Vixster to provide Ashe County with a list of all registered Vixster haulers operating in Ashe County – encompassing names, and associated visible numbers displayed on their vehicles.
