Ann,

I spoke to the citizen that you transferred to me earlier today. She is sending a petition from citizens in the Lansing Fire Service District requesting that they be switched to the Pond Mountain Fire Service District for both tax and insurance district purposes that she would like presented to the commissioner at their August 7<sup>th</sup> meeting. I have attached a copy of the applicable NC General Statute. Per the statute, the commissioners must set a public hearing prior to taking any action on the request. A findings report must be issued and must be available for viewing by the public for two weeks prior to the public hearing. I will work on the findings report if the commissioners so desire.

It is my understanding that the citizens in the petition are outside of Lansing Fire Department's 6-mile insurance district which puts them in a class 10 for fire insurance purposes. Changing them to the Pond Mountain Fire Department would cut the cost of their homeowner's insurance in half.

**§ 153A-304.3. Changes in adjoining service districts.**

(a) Changes. — The board of county commissioners may by resolution relocate the boundary lines between adjoining county service districts if the districts were established for substantially similar purposes. The boundary lines may be changed in accordance with a petition from landowners or may be changed in any manner the board deems appropriate. Upon receipt of a request to change service district boundaries, the board of county commissioners shall set a date and time for a public hearing on the request prior to taking action on the request.

(b) Report. — Before the public hearing required by subsection (a) of this section, the board of county commissioners shall cause to be prepared a report containing all of the following:

- (1) A map of the service district and the adjacent territory showing the current and proposed boundaries of the district.
- (2) A statement indicating that the proposed boundary relocation meets the requirements of subsection (a) of this section.
- (3) A plan for providing service to the area affected by the relocation of district boundaries.
- (4) The effect that the changes in the amount of taxable property will have on the ability of the district to provide services or to service any debt.

The report shall be available for public inspection in the office of the clerk of the board for at least two weeks before the date of the public hearing.

(c) Notice and Hearing. — The board shall hold a public hearing before adopting any resolution relocating the boundaries of a service district. Notice of the hearing shall state the date, hour, and place of the hearing and its subject, and shall include a statement that the report required by subsection (b) of this section is available for inspection in the office of the clerk to the board. The notice shall be published at least once not less than one week before the date of the hearing.

(d) Effective Date. — The resolution changing the boundaries of the districts shall take effect at the beginning of a fiscal year commencing after its passage, as determined by the board. (2005-136, s. 1.)

## **REASONS FOR PETITION**

- 1) Nearly everyone on the petition lives within 1-2 miles of Pond Mtn. Fire Station 3 whereas Lansing Fire Dept. is a minimum of 6 to 8 miles away.
- 2) Unacceptable response times for emergencies are common with Lansing Fire Dept. to our community
- 3) Recent emergency calls have not been answered by Lansing whereas Pond Mtn. has now become the first Dept. to arrive to help.
- 4) By living within the 1-2 miles area around Pond Mtn. station 3 most of us can receive a reduction in our home owners insurance since we, under Lansing jurisdiction, live outside the 6 mile limit, and we experience higher premiums imposed by most home owner insurance companies.
- 5) Pond Mtn Station 3 personnel appear to be more familiar with our community and know the roads and properties better than Lansing.

## **PETITION FOR FIRE DISTRICT ELECTION**

In accordance with North Carolina General Statute § 69-25.11, Changes in Area of District, the **UNDERSIGNED**, being **RESIDENT FREEHOLDERS** living in a district outside the Corporate/town limits of Lansing, North Carolina, which district is described below in this petition and shall hereafter be designated as the **POND MOUNTAIN FIRE DISTRICT**, petition the **BOARD OF COMMISSIONERS FOR ASHE COUNTY** to call an election in said district for the purpose of submitting to the qualified voters therein the question of levying and collecting a special tax on all taxable property in said district of an amount, not exceeding fifteen cents (\$.15) of one hundred dollars (\$100.00) valuation of property for the purpose of providing **FIRE PROTECTION** in said district. This tax is to become effective at the beginning of the next county fiscal year.

The district for which the **FIRE DISTRICT ELECTION** is sought to lie within the following approximate boundaries and is based on current NCDOT maps.

### **PROPOSED ANNEXED FIRE DISTRICT**

Beginning at point (1) at intersection of Road 1319 (East Big Springs Rd) and Road 1324 (Little Horse Creek Rd) and Road 1355 (Coy Ham Rd) thence easterly approximately .7 miles, including properties, intersection (2) of Road 1334 (Stansberry Rd) and Road 1324 (Little Horse Creek) thence northeasterly, including properties, to a point approximately .5 miles to intersection (3) of Road 1324, (Little Horse Creek Road), Road 1354 (Jont Mountain Road) and Road 1324 (East Little Horse Creek) thence easterly to a point approximately .2 miles, including properties, on Road 1324 (East Little Horse Creek), thence from intersection (4) northerly approximately .4 miles, including properties, to intersection (5) Road 1396 (Lee Woodie Rd) northwest, including properties, .3 miles back onto Road 1354 (Jont Mountain Rd) to intersection (6) Road 1356 (Tucker Road) thence northerly approximately 2.5 miles, including properties, on Road 1354 (Jont Mountain Rd) to intersection (7) Road 1353 (Big Windfall) thence northerly approximately .6 miles, including properties, to intersection (8) of Road 1358 (East Whenlin Ridge Road) thence westerly including all properties approximately 3.5 miles to the intersection (9) of Road 1356 (Tucker Rd) at Meadowview Mennonite Church.
