

RE: Surplus of K9 to Watauga

Summary:

NC GS 160A-274 allows for the sale of governmental property between governmental units. The only requirement is board action approving the sale or exchange.

§ 160A-274. Sale, lease, exchange and joint use of governmental property.

- (a) For the purposes of this section, "governmental unit" means a city, county, school administrative unit, sanitary district, fire district, the State, or any other public district, authority, department, agency, board, commission, or institution.
- (b) Any governmental unit may, upon such terms and conditions as it deems wise, with or without consideration, exchange with, lease to, lease from, **sell** to, or purchase from any other governmental unit any interest in real or personal property.
- (c) **Action under this section shall be taken by the governing body of the governmental unit.** Action hereunder by any State agency, except the Department of Transportation, shall be taken only after approval by the Department of Administration. Action with regard to State property under the control of the Department of Transportation shall be taken by the Department of Transportation or its duly authorized delegate. Provided, any county board of education or board of education for any city administrative unit may, upon such terms and conditions as it deems wise, lease to another governmental unit for one dollar (\$1.00) per year any real property owned or held by the board which has been determined by the board to be unnecessary or undesirable for public school purposes. **RESOLUTION FOR THE SALE OF COUNTY PROPERTY
TO ANOTHER GOVERNMENT UNIT**

WHEREAS, G.S. 160A-274 authorizes counties and other governmental units to exchange, lease or sell property by methods outlined therein; and

WHEREAS, the Sheriff's Office desires to sell "Raven", an in-service K9 unit; and

WHEREAS, G.S. 160A-274 states that the County may exchange, lease or sell any real or personal property to another governmental unit if approved by the governing board upon such terms and conditions as it deems wise; and

WHEREAS, G.S. 160A-274 states that prior to the exchange, lease, or sale, the board must adopt a resolution or order authorizing an appropriate county official to authorize the transaction;

NOW, THEREFORE, BE IT RESOLVED by the Ashe County Board of Commissioners, Jefferson, North Carolina, that the county manager or his designee is authorized to sell the above property.
