This intent of this letter is to show compliance with the memorandum of agreement between the County of Ashe and Gabe Miller signed 11/20/2017 by Sam Yearick and Gabe Miller. As of 10/29/2019, Mr. Gabe Miller is in compliance with the agreement. As indicated in #4 of that agreement, a two year period will begin on November 4th, in which Mr. Miller has committed to keeping the property junk/trash free. After the two year period, the County will cancel the full judgement lien of \$22,906.53 against the parcel shown in "exhibit A" in the agreement. Any future complaints of junk or trash at the property shown in "exhibit A" will be assessed and will be addressed with Mr. Gabe Miller.

The above assessment of the agreement will be presented to the Ashe County Board of Commissioners at their meeting on November 4, 2019 starting the two year period.

MEMORANDUM OF AGREEMENT

This MEMORANDUM OF AGREEMENT by and between ASHE COUNTY (First Party) and GABRIEL MILLER (Second Party).

WITNESSETH:

THAT WHEREAS, the Second Parties are the owners, by inheritance of, a 19.66 acre tract of land, Tax Parcel No. 09342-009, located on Old Wilkesboro Road, and;

WHEREAS, the Second Parties also have authority over Tax Parcel No. 09342-037 adjacent to the above referenced tract, and;

WHEREAS, the County has a Judgment Lien against Parcel No. 09342-009 in the amount of \$ 22,906.53 resulting from cleanup of that property ordered in File No. 07-CVD-295, and;


WHEREAS, there is additional cleanup which needs to be done on both properties, which the COUNTY wants to be done, and which the Second Parties are willing to do on the following conditions:

- 1. That the Second Parties will undertake the cleanup of Tax Parcel No. 09342-009 and 09342-037 for the portion of the property visible from Old Wilkesboro Road of all existing "junk", which will be specifically identified and agreed upon by the Second Parties and the County Manager prior to the commencement of cleanup; Are to the County Manager prior to the commencement of cleanup; Are to the Clean-up shall include, but not be limited to, removing all junk/disabled vehicles from the properties or right of ways adjoining the properties, tires, paper, scrap metal, or wood scraps, plastic materials, scrap auto parts and anything else not specifically excluded by the county and designated prior to commencement of the clean-up. All such items shall be properly disposed of.
- 2. That excepted from this agreement are the two campers, one located on each of the properties;
- 3. That the Second Parties will have 24 months from the date of this Agreement to complete this cleanup;



4. If the properties remain clean for a period of two (2) years after cleanup and the
Second Parties commit to keeping it junk free, the County will at that time cancel the

County Manager Sam Yearick - Combs Property Discussion

County Manager Sam Yearick told the Board that the County conducted a property cleanup of the RJ Combs property during October 2011. Florence and Gabe Miller contacted the county manager regarding a judgment the County has on the property. Florence Miller inherited the property from RJ Combs. The judgment is \$22,906.53 for the costs associated with clean up of the property. In addition, there is \$10,471.34 in delinquent taxes on this property and two surrounding properties. The county manager proposed that the Millers pay the delinquent taxes on all three properties, and clean up the RJ Combs property and the Billy Hall property in negotiation of forgiving the lien. Commissioner Richardson stated his belief that this would be in the best interest of the County. Vice Chairman Roark suggested that the County forgive the \$22,906.53 lien for clean up of the RJ Combs property if the Millers pay the remaining delinquent taxes, clean up the property, and keep the property clean for a period of 10 years. Florence Miller addressed the Board asking the Board to consider working with them. Commissioner Rhodes would like to hear from the county attorney before a vote is taken regarding the suit filed by the Combs in 2014 against the County to see if that would affect the decision made today. Gabe Miller answered that Tommy Combs name will be taken off the property and it will be in his mother's name, Florence Miller. He agreed to clean up the property that is going to his mother. Vice Chairman Roark made a motion to forgive the \$22,906.53 lien the County has on the property in return for the Millers to pay all delinguent taxes, for the Millers to keep the property clean for 10 years, for the Millers to have the property cleaned up by July 15, 2017, and for the Millers to keep the property taxes paid on time for 10 years. Commissioner Richardson seconded the motion. The motion passed 3 - 2, with Commissioners Rhodes and Sands voting in opposition stating that they are in favor of the action, but they want the county attorney to review the Combs lawsuit against the County before a vote is taken. **Approved**

the budget for \$543,375 for a new communications system and \$141,524 for communications equipment at the site mentioned. The current communications system was installed in 2006. There have been issues with the equipment within the last few years. Phil Howell, director of communications, talked about the communication systems. There are currently three primary sites. He explained a scenario that took place in October 2016 when the County's VHS system went down. First responders also addressed issues they have been experiencing with the current communications system and the need for an improved system. Wireless representatives explained that they have been working on the system for two years. Some of the components used in the current system are not manufactured anymore. They believe adding a fourth tower in the Creston area is critical for the communications system. Improvements to the current system would be made in two phases with the first phase being an upgrade in the current three sites and the second phase being the addition of a tower in the Creston area. Commissioner Rhodes then made a motion to pursue negotiations with a potential landowner for a new tower site. Commissioner Rose seconded the motion. The motion passed with unanimous approval.
