Re: Replacement of Vehicles

This letter is to request the approval of funds and signature from Ashe County Finance Director Sandra Long on an Intent to purchase letter addressed to Town of Ridgetop, TN. The intent to purchase letter will be required for the Town Council of Ridgetop to remove the listing of the vehicles from the website GovDeals and hold them for the County of Ashe. The request for funds transferred into capital outlay / Vehicles 10.431.540.00 would be to purchase 3 of surplus Law Enforcement Vehicles from the town of Ridgetop, TN. The funds to be appropriated would come from a combination of insurance from Sedwick insurance and Penn National insurance reimbursements that stem from the declaration of total loss on two Sheriff's Office Ford Explorers (VIN # 1FM5K8AR9JGA1 5807, 1FM5K8AR4KGA1 1990) and funds moved from Maintenance/Repair of Vehicles 10.4310.353.00 to ensure costs are covered if insurance reimbursements are not the necessary amount to complete the purchase. The Cost of each below listed Vehicle is \$16,000 for a total amount of \$48,000, this includes necessary equipment for patrol vehicles and will allow for immediate use by our patrol officers. The Contact person at the town of Ridgetop, Dan Seabach, has advised us all vehicles are in good working order and are simply surplus. Pending the approved appropriation of funds by the Ashe County Commissioners during the scheduled meeting November 18th, 2019 the below listed will be purchased by the County of Ashe and used for law enforcement purposes.
