The first item presented by DSS Director Tracie Downer was the Energy Programs Outreach Plan for approval by the Board. Vice Chairman Rhodes made a motion to approve the Plan as presented. Commissioner Dix seconded the motion. The motion passed with unanimous approval.

Department of Social Services Director Tracie Downer presented the monthly departmental update. She told the Board that the number of children needing foster care and the number of adult wards in Ashe County continues to remain high.

Next, DSS Director Tracie Downer presented information regarding Traverse software for use by the Department of Social Services. She explained that electronic files would replace paper files allowing workers in the field the opportunity to see cases live. Supervisors would be more effective because of the ability to collaborate in real time with social workers. Due to the availability of COVID-19 funding, DSS now has the opportunity to purchase the software. Chris Mease with Traverse utilized a PowerPoint presentation to highlight how the software works and how it could benefit Ashe County. He explained how the program reads through a case file and surfaces all pertinent information about a case for the social worker. In addition, all case file information is available through a mobile device. The software allows for less interaction with the public and allows for working from remote locations. DSS Director Tracie Downer told the Board that COVID-19 funding will pay for implementation costs and the yearly annual fee for this year. The County will need to budget costs of the software into next year's budget which will be approximately \$37,000. Discussions have been held regarding the capability of transferring current Laser Fiche file storage licenses used in DSS to the Human Resources Department.

The Board will need to have a copy of the contract to consider before taking action on this request. This item will be added to the August 3, 2020 agenda for consideration.
