20-128 Paramedic Program

Brian Yates, CEO of Ashe Memorial Hospital, introduced Cody Darnell to provide information on the Ashe Community Paramedic Program. The program is paid for through a Duke Endowment Grant in the amount of \$375,000 awarded on January 1, 2018 for three and one-half years to Ashe Memorial Hospital. The mission of the Community Paramedic Program is to improve the quality of life for patients by bridging gaps to health care by paramedics in an outpatient setting. Paramedics are able to help people with

management of chronic disease and reduce the number of visits to the emergency department, readmissions to the hospital, and EMS calls. Patients are put first and their specific needs are focused on. The presentation focused on goals that have been met, the number of patients that have been assisted through the program, savings realized due to decreased hospitalizations and emergency visits, and management of chronic diseases. Also presented was information on grant funding for the program and on an anticipated budget deficit that will occur by July 1, 2021. Plans are to explore additional funding opportunities and to request that the commissioners appropriate funds in the County budget to cover the funding shortfall. A funding request will be made to the commissioners January 2021.

DSS Director Tracie Downer reviewed departmental statistics for June 2020. The year ending numbers show increases in services provided this past year. There has been a reduction in the number of cases in Child Protective Services which will likely increase when school starts. The number of children in foster care remains stable and there are now 24 licensed foster homes in the County. Family Support Services cases have all been processed in a timely manner. There are currently 29 children on a waiting list for childcare subsidy. The Department of Social Services is under budget by 12% this year, which is equivalent to \$1,048,263. DSS Director Tracie Downer updated the Board on Personal Protective Equipment available for providing services due to COVID-19. Also presented was an organizational staff chart and a letter from the Department of Health and Human Services regarding additional benefits available for Food and Nutrition Services recipients.

Airport Advisory Board Chair Tom Breggar spoke to the Board regarding a request for an extension to the hangar lease for Bob Clifton. He told the Board that the Airport Advisory Board met and made a recommendation for the commissioners to extend the lease as requested by Mr. Clifton with new recommendations. He explained that a lease extension is advantageous to the County and lease extensions have been granted in the past. Commissioner Dix recommends that the commissioners allow the advisory board to work with the county manager to formulate a policy addressing hangar lease extensions. Recommendations for additions to the policy include a ten-year extension of the lease

term, the current square footage rate will apply at the time the lease is extended, the current tax rate will apply at the time the lease is extended, and there would not need to be commissioner approval for an amendment to a hangar lease, only approval by the Airport Advisory Board and the county manager. The request for Bob Clifton's lease extension will be presented to the Board at the next meeting after approval of the policy. Mr. Breggar also presented an income and budget summary to the Board. The budget summary shows that the airport is not an expense to the County.
