## **Composition of the HCCBG Planning Committee**

In each county, the Board of Commissioners is charged with appointment of a committee responsible for planning/coordinating the development of the County Funding Plan for Home and Community Care Block Grant Services (HCCBG). The advisory committee must represent a broad range of aging interests to effectively build consensus on the County Funding Plan. A viable committee will not be viewed as being predisposed toward certain providers or favoring specific interests.

Representation should include the following:

- Area Agencies on Aging (must be represented on committee if not designated as the County Lead Agency)
- Aging service providers (public, private nonprofit, and for-profit)
- Local elected officials and civic leaders
- Older consumers (the Division of Aging and Adult Services strongly recommends that older consumers comprise no less than one-third of the Advisory Committee Membership)

The committee shall function as a resource to the County Lead Agency by obtaining input from provider interests, older consumers, and their families and providing consensus on the contents of the County Funding Plan.
