He explained the different types of plan options and detailed the areas that Vaya Health serves. Although Vaya Health's service area is increasing from 22 counties to 31, Mr. Shepherd added that the newly added counties are similar to the original 22 and that Vaya is good at serving small communities in more rural areas.*

*Appalachian Regional Library Director of Libraries Jane Blackburn introduced to the Board Laura McPherson, the new Ashe County Librarian. Ms. Blackburn also presented the library's Fiscal Year 2020-2021 annual report, noting that the year saw a 13% increase in cardholders over the last pre-COVID year (FY18-19). She also pointed out that the region's libraries served as key Wi-Fi access points with the number of users increasing from approximately 38,000 in FY18-19 to 139,000 in FY20-21. Ms. Blackburn also described a new four-year plan and shared specific goals for the Ashe County Library.*

County Manager Adam Stumb shared with the Board an update regarding plans for new Department of Social Services (DSS) and Health Department buildings. He explained that he had been working with architects to project growth and space needs until 2040, while also taking into consideration requests from DSS staff to have all DSS employees in the same building with individual offices and better security features. DSS Director Tracie Downer expanded on the department's requests and explained how the preferred changes would increase the efficiency of the department and augment confidentiality. County Manager Stumb noted that the challenge in these projects would be finding the balance with enough room for growth but not more than is needed, and he said that plans for these buildings will be an ongoing discussion.
