#### MISC 17-6

Reclassification of Vacant Sergeant Position in the Narcotics Division to an Administrative Captain Position Increasing the Pay Grade from 66 to 71

Sheriff Buchanan explained his request to reclassify a sergeant position in the Narcotics Division to an administrative captain position at the Sheriff's Department. He told the Board that the position was removed during the last administration. The employee would work in administration and as a fill-in lieutenant in the patrol division. Commissioner Sands stated that he would prefer to make a decision on filling this position during the annual budget review that will take place in several months. Commissioner Rose made a motion to approve the request. Commissioner Rhodes then asked for specifics regarding funding for the position. County Manager Sam Yearick explained that an appropriation of \$9105 would need to be made for the position plus any needed Contingency Fund appropriations. The amount will need to be noted at an upcoming meeting of the Board. With no further questions, Commissioner Roark seconded the motion. The motion passed with unanimous approval.

#### MISC 17-8 Discussion & Possible Action on Sheriff's Salary

County Manager Sam Yearick opened discussion regarding the pay grade for newly appointed Sheriff Buchanan. After reviewing G.S. 153A-92 which deals with classification plans, he determined that the pay grade should be increased from 78 to 80. The county manager referenced the pay grade change from 78 to 80 made when Sheriff Williams was elected. The County pay classification plan failed to reflect the increase in the pay grade for the sheriff's position. Commissioner Rhodes clarified the action taken by the Board during the FY2010 budget work session meetings. The Board increased the pay grade to 80 due to job responsibilities and out of appreciation for the job Sheriff Williams was doing. However, the Board did not increase the pay grade on the County pay plan. Commissioner Roark then called Sheriff Buchanan to the podium and asked if he had been contacted by former Sheriff Williams regarding this issue. Sheriff Buchanan told the Board that he has a recorded call from the former sheriff explaining the need to be increased to pay grade 80 if the commissioners would like for him to play it. The Board declined listening to the recording. Sheriff Buchanan also told the Board that he contacted the Sheriff's Association and was told that he should be on the same pay grade that the outgoing sheriff was on. With no further discussion, Commissioner Rose made a motion for the county attorney to research this issue before a vote is taken by the Board. Commissioner Rhodes seconded the motion. The motion passed with unanimous approval.

MISC 17-9 Ashe County Partnership for Children Lease Proposal

County Manager Yearick told the Board that he met with the Partnership for Children Board to discuss the lease for Family Central with the County. The Partnership for Children no longer wants to lease the Family Central facility from the County. The outstanding balance on their loan with the USDA is \$223,130 with annual payments in the amount of \$38,440. Chairman Sands told the Board that he used to serve on the Partnership Board and he was in the same meeting with the county manager and the Partnership Board. The Partnership for Children serves over 1000 children and 800 families each year. He added that the Partnership has spent \$1.5 million in upgrades on the building. In 2000, the Partnership borrowed \$500,000 from USDA. For 16 years they have managed and cared for the building. But there are fewer renters and the Partnership cannot survive now. Chairman Sands suggested that the County pay off the loan and take over the facility. The Partnership for Children could then lease from the County. Kim Barnes and David Blackburn representing Ashe Partnership for Children were present to answer questions from the Board. Ms. Barnes told the Board they the Partnership brings in \$650,000 each year in program monies to serve families and \$145,000 in subsidy funds to serve children. In answer to a question from Commissioner Roark, Ms. Barnes answered that costs to upkeep the building amounts to \$102,000 a year. David Blackburn told the Board that the County is already paying \$128,000 to Family Central for space used by Wilkes Community College, DSS, and the Sheriff's Office. In addition, the County would receive money from renters. In less than two years, the County would receive enough money to pay off the USDA loan. The County is already in control of the gym and ballfields. Mr. Blackburn told the Board that the facility is used by a lot of citizens in Ashe County. Commissioner Rhodes made a motion based on the information provided to look at taking over lease payments or paying off the loan. Commissioner Rose seconded the motion. The motion passed with unanimous approval. **Approved**
