Beth Lovette, director of the Appalachian District Health Department, presented the Health Department's annual report. The Appalachian District Health Department is one of only six district health departments in the state. Being a district department is driven by population which saves money and resources. The counties included in the district are Alleghany, Ashe and Watauga counties. The Health Department encompasses three main areas that serve the citizens in our three-county region. Those include clinical services such as immunizations, pre-natal care, lab services, and dental services. There are prevention services, such as septic and well permitting, food and lodging inspections, and tobacco control programs. The Health Department also works to track communicable diseases and other health data across our district.

Mr. Nelson was not able to attend the meeting. The Board opened discussion regarding a complaint received last fall about barking dogs. Chairman Sands read minutes from the October 24, 2016 Board meeting when a citizen asked the Board to consider adopting an ordinance to address barking dogs. Animal Control Director Joe Testerman told the Board that he talked with animal control officers in approximately 15 North Carolina counties similar in size to Ashe County or surrounding Ashe County. Those counties that have an ordinance to address barking dogs are enforced by the Sheriff's Office, but a lot of counties do not enforce regulations because they are not enforced in court. It was recommended for individuals that are having problems with neighbors that have barking dogs to remedy this issue through civil court. Commissioner Roark also mentioned that there is a lot of acreage in the Farmland Preservation Program in Ashe

County which has to be taken into consideration. Mr. Testerman added that the County does enforce issues with roaming dogs. The commissioners were in agreement to not take any action on creating an ordinance to address barking dogs.

PRES 17-20 A Safe Home for Everyone (ASHE) Director Deanna Stoker - Annual Report

Deanna Stoker, director of A Safe Home for Everyone (ASHE), presented the annual report for ASHE to the commissioners. There was a 65% increase in domestic violence crimes and sexual assault in 2015. In 2014 there were 146 people directly impacted by domestic violence and that number increased to 207 in 2015. From July 2016 through the end of February 2017, ASHE has assisted 184 people proving that this year may top last year's totals. Not only does ASHE assist victims, they also provide community education and outreach. Rev. Michael Lea, senior pastor with West Jefferson First Baptist Church and highly involved with the Homeless Coalition in Ashe County, spoke to the assistance they receive from ASHE for people that come to them that are in need. Both organizations also receive assistance from ASHE in the form of training and resources. He told the Board that the majority of people that receive assistance from ASHE are children and women, largely due to domestic violence.

Patricia Calloway, executive director of Ashe Services for Aging, asked the Board to approve membership of the Home & Community Care Block Grant Planning Committee. Finance Officer Sandra Long made a request for the Board to approve a fund balance appropriation to the Partnership for Children for the USDA loan payoff. At the February 20, 2017 Board meeting, the commissioners agreed to pay off the loan or to take over payments of the loan for the Family Central building. County Manager Sam Yearick believes the best way to proceed is to pay off the loan through a fund balance appropriation and not involve the Local Government Commission through borrowing money to pay off the loan. The County will take over the Family Central facility on April 1st. Commissioner Rhodes made a motion to pay off the loan with USDA for the Family Central facility through an appropriation of \$223,025 from the County Fund Balance. Commissioner Roark seconded the motion. The motion passed with unanimous approval.

Commissioner Roark made a request for the Board to appropriate \$60,000 to pay for an air study at Family Central due to asbestos being in the building. Chairman Sands would like the county manager and county maintenance director to talk with Kim Barnes, executive director of Partnership for Children, before an air study is done. Commissioner Roark referenced the need to tear down the Eller House. Commissioner Rhodes suggested looking at the possibility of giving the Eller House to Habitat for Humanity and would like more study done before an appropriation of funds is made. Commissioner Rhodes made a motion to table the request for a \$60,000 appropriation to pay for an air study at Family Central. Vice Chair Perry seconded the motion. The motion passed with unanimous approval.
