## V. Public Comment

Chairman Sands opened the floor for Public Comment.

Bob Egan, who lives off Silas Creek Road and moved to Ashe County from Dare County six years ago, spoke to the Board regarding a mobile home that burned two years ago. The mobile home is located close to where he lives. He contacted County staff requesting to have the mobile home removed. The owner of the mobile home does not have the money to move it. Mr. Egan also spoke regarding a house in Piney Creek that burned over a year ago. He asked why the County doesn't do something about these properties. In addition, Mr. Egan spoke to the Board about Old Field Creek Road which is what he considers the worst road in the County containing potholes and ruts. He asked why the County does not repair the road.

Judy Bare of West Jefferson spoke to the Board regarding the open position for a Family Consumer Sciences Agent. She explained that the people interviewed for the position had no experience in the responsibilities required of this position. Ms. Bare spoke of the importance of this position to the citizens of Ashe County. The County is responsible for a portion of the salary for the position and she expressed the need for this position to be approved in the budget.

Rose Price of Creston read a letter from Sheriff Buchanan to the Board of Commissioners when he was appointed sheriff. She addressed several statements made in the letter.

A public hearing was held regarding adoption of the County's FY2017/18 Budget. Chairman Sands opened the public hearing for the FY2017/18 County of Ashe Budget at 9:13 a.m. No comment was offered and the public hearing was closed at 9:14 a.m. Commissioner Rose made a motion to appropriate \$17,500 to Cooperative Extension to fund 1/3 of the Family Consumer Sciences position with the salary and benefits to be shared equally between Ashe County and N.C. State University. This will increase the Cooperative Extension budget from \$354,478 to \$371,978. Commissioner Rhodes seconded the motion. The motion passed with unanimous approval. Commissioner Rhodes then made a motion to adopt the FY2017/18 County Budget at \$43,307,970 and to:

Set the ad valorem tax rate at - 44.3 cents (per \$100 of assessed value) increasing the ad valorem tax rate 1 cent to be designated for Ashe Memorial Hospital, and to set fire tax rates (per \$100 of assessed value) as follows:

Economic Development Director Cathy Barr told the Board that Northwestern Emergency Vehicles will be creating 30 new jobs over the next four years due to expanded production resulting from the purchase of the old Tigra facility. Northwestern Emergency Vehicles received a Building Reuse Grant in the amount of \$187,500 that will be used for renovation of the building. A 5% funding match (\$9357) from the County is required in the grant. Chairman Sands opened the Public Hearing at 9:20 a.m. No comment was offered. Chairman Sands closed the Public Hearing at 9:21 a.m. Commissioner Rhodes made a motion to approve \$9357 in matching funds required by the Building Reuse Grant for Northwestern Emergency Vehicles. Commissioner Rose seconded the motion. The motion passed with unanimous approval.

Lou Zeller, director of Blue Ridge Environmental Defense League, presented a resolution supporting action regarding the air quality permit issued by the Division of Air Quality for the Glendale Springs Asphalt Plant. Mr. Zeller reviewed his prior presentation and the letter requesting reopening of the air quality permit for the proposed asphalt plant in Glendale Springs which was presented at the June 5, 2017 meeting of the commissioners. Commissioner Rhodes made a motion to approve the resolution as presented. Commissioner Rose seconded the motion. Commissioner Rhodes requested

that the resolution be forwarded to local legislators, state representatives, and the governor. The Board agreed and the motion passed with unanimous approval.

At the close of the Commissioner Comments portion of the meeting, County Attorney John Kilby requested to update the Board on the issue. He explained that the resolution just presented by Mr. Zeller was revised this morning by the attorney representing Ashe County in the lawsuit brought by the asphalt plant. The county attorney requested the commissioners adopt the revised resolution which includes five specific resolves addressing issues with the asphalt plant including not only air quality but water quality. He will also obtain advice from counsel on who to direct the resolution to. Commissioner Rose then made a motion to rescind the previous motion made by Commissioner Rhodes and to now approve the amended resolution presented by County Attorney Kilby. Commissioner Rhodes seconded the motion. The motion passed with unanimous approval.
