WORK SESSION - 8:30 AM

Chairman Sands opened the Work Session at 8:30 a.m. in the second floor conference room at the Ashe County Courthouse.

Chairman Sands reminded the Board that pictures will be taken with the commissioners and a group of Boy Scouts at New River State Park at 1:00 p.m. today.

County Manager Sam Yearick told the Board that the North Carolina Association of County Commissioners Conference will be held in Durham beginning on Thursday.

Chairman Sands has been approached by several citizens with a request to hold commissioner meetings later in the day. A request was also made for the commissioners to hold a Public Forum to allow citizens an opportunity to express concerns regarding issues in the County. This will be added as an item of discussion by the Board on the August 21, 2017 agenda.

Next, Chairman Sands reviewed items on the meeting agenda.

County Manager Yearick told the Board that Environmental Services Director Scott Hurley has concerns on whether the vehicles belonging to Vixster, LLC subcontractor will be clearly marked when they bring trash to the landfill. Commissioner Rhodes requested that the county attorney review the contract with Vixster, LLC prior to the next meeting of the Board.

Emergency Management Coordinator Patty Gambill provided information regarding the request from Warrensville Volunteer Fire and Rescue for an ambulance franchise ordinance. Warrensville wants to provide backup service to Ashe Medics. She told the Board that Warrensville Volunteer Fire and Rescue has passed state inspection.

Ms. Gambill also updated the Board on the petition for election of a fire district on the agenda. She suggested that the fire departments hold a meeting and discuss this before the Board takes action.

With no further comment, the Work Session was closed at 8:53 a.m.

Chairman Sands stated that the Board discussed this during the earlier Work Session. The Board will need to discuss the suggestion and vote on this. Ms. Price added that the meeting needs to be advertised so the public will know of the meeting and that citizens need to have the opportunity to speak.

Donald Nelson referred to a Public Records Request that he submitted in May. He said that he has not heard anything from the County in response to the request. Three weeks ago County Manager Yearick reassured Mr. Nelson that the request for records is being worked on. Mr. Nelson stated that the records custodian is three months behind on records requests. He believes the commissioners and county manager need to get additional help in that office.

Sheriff Buchanan spoke to the comments made by Ms. Price. He explained that he has an open-door policy and will meet with anyone at any time and with as many citizens as possible.

Zak Ammar, CEO of Vixster, LLC, was present for the second reading of his application for a Solid Waste Franchise. His company would like to provide residential trash collection to the rural areas in Ashe County. A Letter of Intent was presented to the commissioners from Mr. Ammar with a request to waive residential dumping fees. County Manager Yearick explained that the Ashe County Solid Waste Ordinance allows customers of a franchised garbage hauler to request a refund of the annual \$130 Solid Waste Disposal Fee. Due to that, Mr. Ammar's request for a waiver of residential dumping fees was not approved. With no further discussion, Commissioner Rhodes made a motion to approve the Solid Waste Franchise for Vixster, LLC. Commissioner Rose seconded the motion. The motion passed with unanimous approval. The Board did not vote at the first reading of the franchise application on July 17, 2017 which will result in the need for one additional reading of the franchise. This will be added to the August 21, 2017 agenda and the county attorney will review the contract prior to that meeting. **Approved**

The back-up providers are not in competition and do not charge for services.

Ross Mast presented a petition to move property owners from the Lansing Fire District to the Pond Mountain Fire District. Each property owner within two miles of the new Pond Mountain Meadowview Substation were contacted regarding the petition. Mr. Mast told the Board that there have been several times that the Lansing Fire Department was the third department to arrive on the scene of an emergency in their area. By changing the fire district, the affected property owners will receive lower insurance rates since they are two miles from the new substation. Chairman Sands explained to Mr. Mast that this was discussed in the Work Session held earlier today. The Board agreed to allow the two affected fire departments to meet and discuss this request. Emergency Management Coordinator Patty Gambill referenced requirements that must be adhered to in the General Statutes if the property owners move to a different fire district.
