### IV. Adoption of Agenda

Chairman Sands stated that two items need to be added to the Executive Session for discussion scheduled on today's agenda: Appalachian Materials lawsuit and Tommy Combs lawsuit. Commissioner Roark requested that the Board discuss placing a county-wide referendum on the November ballot regarding the issue of adding the National Motto to all County-funded buildings, particularly Ashe County school buildings. Vice Chairman Perry asked for an update regarding changing the probationary period of County employees. County Manager Sam Yearick answered that this will be placed on a future agenda. Commissioner Rose made a motion to adopt the agenda with the addition of discussion regarding the Appalachian Materials lawsuit and the Tommy Combs lawsuit during Executive Session.
