V. Public Comment

Chairman Sands opened the floor for Public Comment.

Larry Dix spoke to the Board requesting to be considered for the vacant seat on the Ashe County Board of Commissioners. He explained that when the Executive Committee of the Republican Party met recently that there was a question regarding the General Statute requirement for a candidate to be a member of the party for 90 days before being eligible to be appointed to the commission board. After research was conducted into statute requirements, an interpretation was made that the 90-day rule applies when a person is to be elected to the position, but not for appointment to the position. Mr. Dix also listed his experience and work history along with the desire to serve the citizens of Ashe County.

No further comments were made.

<u>18-124</u>	Created by the Resignation of Commissioner Gary Roark

Chairman Sands reviewed General Statute requirements for filling the vacant position on the Board of Commissioners as provided for under G.S. 153A-27. The requirements include for the replacement to be made by the Board of Commissioners within 60 days of the vacancy and that a replacement be of the same political party. The executive committee of the appropriate political party should be consulted for nominations to fill the position but the commissioners are not bound by the recommendations. If the commissioners are unable to fill the vacancy within 60 days, the responsibility to fill the position moves to the Clerk of Court who has 10 days to fill the position. The following individuals were recommended by the executive committee of the Republican Party: Terry Sexton, Todd McNeill, and John Wheeler. With no further comments, Commissioner Rhodes made a motion to appoint Todd McNeill to fill the vacant position created by the resignation of Gary Roark on the Board of Commissioners. Vice Chairman Perry seconded the motion. The motion passed with unanimous approval.

9:20 AM - Chief Deputy Rick Clayton - Update Regarding Jail Inmate Population

Chief Deputy Rick Clayton provided an update regarding the jail inmate population through November 2017. The Statewide Misdemeanant Confinement Program has brought in \$284,795.41. This program includes state inmates convicted of a misdemeanor and sentenced to more than 90 days in a county jail. Housing of out-of-county inmates has brought in \$215,840 through the end of November. Chief Deputy Clayton explained that these totals exceed the projected revenues by \$50,000 and they are now projecting a total revenue in these two programs of \$1 million through June 2018.

A request was also made for \$20,000 from Asset Forfeiture Funds (monies from the federal government for law enforcement seizures of properties) to outfit four new vehicles and for maintenance and repair of vehicles. He told the Board that there is approximately \$55,000 in the fund. Commissioner Rose made a motion to appropriate \$20,000 from Asset Forfeiture Funds as requested. Vice Chairman Perry seconded the motion. Commissioner Rhodes stated concern for the line item budget reduction made during the budget work sessions. With no further comments, Chairman Sands called for a vote to the motion on the floor. The motion passed 4-0, with Commissioners Sands, Perry and Rose voting in favor of the motion. Commissioner Rhodes abstained from voting resulting in a vote in the affirmative.

The Hazard Mitigation Plan includes background on each county and municipality, an overview of past disaster damages, an assessment of natural hazard risks, what capabilities local governments have in general, and what their specific capabilities are. It also outlines mitigation goals, objectives and strategies created by the High Country Regional Hazard Mitigation Planning Committee which includes the emergency management coordinators of each county and other officials from the jurisdictions included in the plan. The goal of hazard mitigation planning is for local governments to take steps to reduce or eliminate long-term risk to human life and property from natural hazards, as well as reduce disaster recovery costs.
