PRES 19-206 9:05 AM - Finance Officer Sandra Long - Landfill Compactor Financing Approval

Finance Officer Sandra Long presented information to the Board regarding purchase of a compactor for the landfill. General Statues stipulate that the State solicit the best price for purchase of large equipment such as a compactor. Requests for Proposals (RFPs) for financing of the compactor were sent to five banks and two of those banks responded. First Citizens Bank sent a proposal with a financing rate of 2.27% and First National Bank sent a proposal of 2.14% for a five-year loan period. Vice Chairman Rhodes made a motion to approve the proposal from First National Bank for a financing rate of 2.14% with a five-year loan term and the signature approval of Sandra Long, Angela Eggers, and Ann Clark for the financing documents. Commissioner Perry seconded the motion. The motion passed with unanimous approval.

Elections Director John Shepherd introduced Elections Board members attending the meeting. He presented a request for the Board to approve the purchase of new voting equipment. Current equipment was purchased in 2005 with federal grant monies. The equipment is aging and beginning to have problems and replacement parts are not available. The new equipment is optic scan equipment. Thirty-four counties have already purchased the equipment. A detailed explanation of the equipment was provided. The cost of the equipment is \$220,000. There is a loyalty discount of \$13,000 if the new equipment is purchased before January 1. The current service agreement is \$19,000 and the service agreement charge for the new equipment will drop to \$10,000 per year. The company will accept one-half of the total payment this year and the other half during next year's budget at no interest. Commissioner Sands made a motion to approve the

purchase of new voting equipment from Election Systems & Software as recommended by the Board of Elections for \$220,000 with one-half of the amount paid this year and one-half to be paid during the FY 2020/2021 budget year. Vice Chairman Rhodes seconded the motion. The motion passed with unanimous approval.

Lonnie Jones and Ramona Renfroe with the Museum of Ashe County History were present to update the Board on roof repairs made to the 1904 Courthouse. Lonnie Jones thanked the Board for the funds that were appropriated to pay for the repairs. He explained that when the roof was removed, the workers found that it was not as bad as originally thought. The cost of repairs was \$19,337. There are other small repairs that need to be made and the Museum of Ashe County History will pay for these. Museum Director Ramona Renfroe told the Board that they average 15,000 visitors per year and thanked the Board for their support.
