Tax Administrator Chris Lambert presented a request for approval by the Board to allow him to consider two untimely Present Use Value applications. One application was included in the packet and will be considered first. Commissioner Dix made a motion to approve the application as presented. Commissioner Perry seconded the motion. Vice Chairman Rhodes opened the floor for commissioner comments. Commissioner Sands stated that the Board needs to be consistent with action taken on these requests. Tax Administrator Lambert stated that historically the commissioners do not approve untimely applications. Commissioner Perry stated that this is the first request that she has seen that should be approved due to the circumstances surrounding the request. Commissioner Dix agrees that the Board should be consistent, but believes the Board needs to look at each situation. Vice Chairman Rhodes stated that over the years there have been unique situations, but he must vote the way he has down through the years and remain consistent. With no further comments, the vice chairman called for a vote to the motion on the floor. The motion failed with a vote of 2 - 2; Commissioners Rhodes and Sands voted in opposition. Since the second application was not included in the packet, to adhere to the Board's Rules of Procedure, this will be considered at the next meeting.

 Understanding - Ashe County CIS Afterschool Program

Extension Director Travis Birdsell provided information on the Ashe County CIS Afterschool Program Memorandum of Understanding (MOU). The document needs to be reworked and will need to be brought back before the Board for approval. He explained that at the end of this school year, Cooperative Extension will no longer be operating the afterschool program. They no longer have the internal support structure from their governing agencies to be able to meet licensing standards. And they can no longer operate without it costing the taxpayers. A group is working to find a way to continue providing services for children which includes kindergarten through sixth grade at the county's three elementary schools. The group is trying to identify another community partner to provide the services due to the announcement last Friday that the Communities & Schools of NC will not be able to provide services. All of the other entities included in the MOU will work together to establish a plan and to notify parents. There are limited agencies available to work with school age and younger children. The school system will be very heavily involved in the program. County Manager Adam Stumb explained that the group has dealt with a lot of setbacks in trying to formulate a plan to provide afterschool care for children. And the hope is that the program will be self-sustaining. Commissioner Perry made a motion to table action on the Memorandum of Understanding. Commissioner Dix seconded the motion. The motion passed with unanimous approval.

PRES 20-47 9:45 AM - Economic Development Director Cathy Barr - Blue Ridge Energy Loan Application Information

Economic Development Director Cathy Barr presented a copy of the Blue Ridge Energy Loan Application for the commissioners to review. The loan would be used to improve property at the new industrial park. The grant would come from the Rural Economic Development Loan Grant program and the applicant for the loan is Blue Ridge Energy. The grant provides an opportunity to apply for a \$1,360,000 USDA loan of which \$300,000 is grant monies. The loan amount would be \$1,060,000 for ten-years at a 0% interest

rate. The application must be submitted by March 30, 2020 and the County will hear back mid-August.
