PRES 20-31 9:05 AM - Sheriff Phil Howell - Recognition of Dispatchers

Sheriff Howell introduced Dispatcher Janna Suttle and Dispatcher Jennifer Bryant whose actions saved the lives of several deputies in the line of duty. Because of their actions, both dispatchers received recognition from the State 911 Board. Each commissioner recognized and thanked the ladies for their service to the public and for the difficult job that they do.

PRES 20-51 9:08 AM - District Health Director Jennifer Greene - COVID-19 Update

Appalachian District Health Director Jennifer Greene provided information regarding action taken, along with preparations being made, by the Appalachian District Health Department regarding the coronavirus. The Health Department's Incident Management Team has been initiated and is working with key departments and agencies. Ms. Greene stated how important it is to make sure the public is aware of the importance that the hospital is not overrun by the worried well. People with concerns can call the Appalachian District Health Department for assistance and support. She reiterated that people that are sick need to stay home and everyone needs to adhere to the governor's guidelines which include limiting mass gatherings to slow the spread of the virus.

Department of Social Services Director Tracie Downer presented the monthly departmental update with statistics for January 2020. She highlighted alerts from the North Carolina Department of Health and Human Services (NCDHHS) regarding the coronavirus. She explained steps being taken to address coronavirus threats and to also continue providing services without clients having to come into the Courthouse. The NCDHHS sent a letter on March 12 highlighting the need to curtail some services due to the danger to workers and in an attempt to stop the transmission of the virus. Director Downer explained modification of certain procedures, the use of telecommuting services, and optional client visits that are being postponed.

Tom Kilby, director of Youth Services of Northwest North Carolina, provided information on the Ashe County Teen Court or Tribal Court which provides an option for juvenile offenders committing a misdemeanor offense. In December 2019, the criminal juvenile age changed from 16 to 18 years of age. The Department of Public Safety provided funding to help establish restorative justice programs to meet the needs of 16 and 17 year old offenders. The Tribunal Court utilizes peer sentencing for juvenile offenders and is led by youth volunteers between the ages of 14 and 18 under the supervision of an adult judge. This provides an opportunity for youth volunteers that may want to pursue a career in the justice system. Juvenile offenders are held accountable for their actions and are given a chance to contribute to their community and to repair and pay for any harm that they caused.

BUDGET AMENDMENTS March 16, 2020

General Fund:

To increase the appropriation for the department of Law Enforcement from \$2,942,493 to \$2,992,493; this increased appropriation of \$50,000 to come from unappropriated revenues from Civil Expense Advancements.

To increase the appropriation for the department of Social Services from \$8,166,034 to \$8,200,509; this increased appropriation to be made with \$34,475 in additional unappropriated CIP and LIEAP revenues.

To increase the appropriation for the department of Human Services from \$1,456,657 to \$1,478,867; this increased appropriation to be made with an additional \$22,210 in unappropriated NCDOT ROAP revenues.

To increase the appropriation for the department of Legal from \$157,260 to \$282,260; this increased appropriation of \$125,000 to be made by reducing the Contingency Fund from \$233,802 to \$108,802.

To increase the appropriation for the department of Fire from \$243,359 to 253,359; this increased appropriation of \$10,000 to be made by reducing the Contingency Fund from \$108,802 to \$98,802.

Enterprise Fund:

To increase the appropriation for the Environmental Services Enterprise Fund from \$3,235,250 to \$3,982,797; this increased appropriation to be made with \$747,547 in loan proceeds.
