V. Public Comment

Chairman McNeill opened the floor for comments from the public.

Via phone call, Sherry Edwards of West Jefferson spoke to the Board regarding the current ban on short-term rentals requesting that the ban not be extended after May 8, 2020. She also asked the commissioners to send a resolution to Governor Roy Cooper requesting that counties be allowed to make their own decisions on reopening businesses. She referred to a resolution recently adopted by the Gaston County Board of Commissioners. No further comments were offered via telephone.

Chairman McNeill read the following two public comments submitted via email.

Susan Carter of Jefferson told the Board that she received a letter from Governor Roy Cooper. Her business, which is a campground located in Crumpler, can continue to operate as long as specified guidelines are adhered to as stated in the letter from the governor.

Next, Chairman McNeill read a public comment submitted by Grace Dillon of Todd. She stated that there are one-million people living a nomadic lifestyle in campgrounds. These people are suffering due to COVID-19 and their needs should be considered carefully.

No further comments were offered.

Priscilla Norris, CPA, presented the County's Audit Contract for year ending June 30, 2020 for approval by the Board. She explained that the State has a new requirement for auditors to examine employee census data and underlying payroll records. This will be a separate engagement from the audit and the fee for this is \$2,400. The regular audit fee is \$44,700 and includes an increase of \$1200 over last year due to additional Governmental Accounting Standards Board (GASB) requirements. Commissioner Sands made a motion to approve the June 30, 2020 Audit as presented. Commissioner Perry seconded the motion. The motion passed with unanimous approval.
