Chairman McNeill opened the Public Hearing at 9:03 a.m. to obtain citizen comments regarding submission of an application for 2020 Community Development Block Grant (CDBG) funds to assist low-income to moderate-income individuals with utility payments or food insecurity resulting from the COVID-19 pandemic. Cory Osborne, regional planner with High Country Council of Governments, provided information on the grant funds. Funds are provided from the NC Department of Commerce. Units of government can apply for up to \$900,000 through this program. Funds are available on a first-come, first-serve basis. The second public hearing required before applying for funds will be held on October 5, 2020. Requirements for use of the funds was listed, along with ineligible usage of funds. There are no matching funds required from the County. Funds must be expended within 30 months of receiving the grant. There was no public comment offered and the Public Hearing was closed at 9:12 a.m.
