Tax Mapping Supervisor Matthew Levi and Kent Rothrock with Highland Mapping provided information on the Mapping Address Project. Matthew Levi provided information through a PowerPoint presentation. The Tax Mapping Department will provide the addressing information that will be used by emergency medical services, the Planning Department, the Building Inspections Department, the 911 Addressing Coordinator, 911 Dispatch, the Tax Administration Department, and the phone companies. Information accessed will be real-time, errors in data will be eliminated, and information will be accessible to the public. The project will also be used for transitioning from the current E911 system to the New Generation 911 system.

County Manager Adam Stumb updated the Board on federal funds received through the Coronavirus Relief Fund (CARES Act) in the amount of \$1.2 million in two different allocations. He reviewed disbursement of the monies to organizations in the County. The county manager requested action to allocate \$30,000 of CARES Act funds to the Sharing Center on a reimbursement basis to continue distribution of food during the COVID-19 pandemic. Vice Chairman Rhodes made a motion to approve the funding allocation of \$30,000 on a reimbursement basis to the Sharing Center. Commissioner Perry seconded the motion. The motion passed with unanimous approval.

9:50 AM - County Manager Adam Stumb - Golden Leaf Grant Applications

County Manager Adam Stumb presented applications submitted for a Golden Leaf Grant. The total grant is \$11 million for the Northwest Prosperity Zone with \$1.5 million for up to four projects in Ashe County. The County received five applications totaling \$4 million. The applications are from the County for the Industrial Park expansion, the Lost Province Center for Cultural Arts, the Agricultural Center, Partnership for Ashe, and Ashe County Schools & Wilkes Community College. County Manager Adam Stumb explained that the County is submitting an application for the industrial park to provide water, sewer, and roads to the site. Next, David Norman addressed the Board regarding an application submitted for the Lost Province Center for Cultural Arts which will preserve and promote Appalachian Heritage arts, crafts, and skills. The Center will boost tourism and provide employment opportunities in our community. The grant's focus is to improve workforce employment for adult workers and create apprenticeships in the areas of culinary, music, and pottery. Judy Bare then presented information on the application for a new Agricultural Center that will be built in Ashe County. Work has been ongoing for this project the last several years. Agriculture is the largest business in the county and the facility can be used by 4H, Wilkes Community College, and Ashe County Schools. She explained that cattle has to be transported out of the county to be sold which is a hardship on cattle farmers. Kim Barnes was next to speak to the Board regarding the Partnership for Ashe application. She explained the childcare crises in Ashe County stating that childcare sites have dropped from 16 sites to only seven sites. There are 277 children under five years of age on a waiting list for childcare. The application is being made to provide funding for an addition to their building that will be used as a training center for early childhood education because there is limited space for training within the County. County Manager Adam Stumb provided information to the Board regarding the projects which have been ranked based on need, money on hand, and availability of other grants. Vice Chairman Rhodes made a motion to submit the following four applications ranked on need: 1) Ashe Industrial Park, 2) Agricultural Center, 3) Partnership for Ashe, and 4) Ashe County Schools & Wilkes Community College. Commissioner Perry seconded the motion. The motion passed with unanimous approval.
