*Diane Harless with Ashe Medication Assistance provided the Board with an overview of the program. She shared that the organization helps Ashe County citizens who lack insurance or have Part D coverage gaps to get necessary medicine. Ms. Harless shared that from May 1, 2020 to May 1, 2021, Ashe Medication Assistance helped clients get \$2.5 million worth of medications such as insulin, heart medication, and blood thinners. Ashe Medication Assistance has been in operation for 22 years and is located at 225 Court Street in Jefferson.*

*County Manager Adam Stumb discussed with the Board the County's Facility Use Policy. He shared that a local organization had requested to use the government complex for a community concert, and he noted that the organization was one of the groups eligible under Item 4 on the policy, pending Board approval. County Manager Stumb also highlighted several conditions for use, including requirement of insurance and thorough cleaning, damage liability, and prohibited items.*

*Ashe County Chamber of Commerce Executive Director Kitty Honeycutt presented for the Board's approval a request to hold a community concert in the parking lots of the government complex on Friday, July 9, 2021. She discussed details about the performers but said that specifics could not be promoted until after June 19, 2021, in keeping with the band's contracts. Ms. Honeycutt said that the show will be family-friendly and free to the public. She also noted that the concert will be a chance to celebrate the resilience of the local community and will also have a notable economic impact due to the band's loyal following. The Chamber will sponsor and host the event with the support of corporate sponsors. Commissioner Olive made a motion to approve the request as presented. Vice Chairman Sands seconded the motion. The motion passed with unanimous approval.*

Mayor Powers requested maintenance support from the County, specifically regular hours from the County's contracted mowing company to assist with mowing and trail maintenance. After discussion by the Board, County Manager Adam Stumb offered to ask the mowing company to provide a quote for the work in Lansing and to provide the information when the contract is presented for approval.*

*Ashe County Schools Superintendent Dr. Eisa Cox requested the Board's approval to move forward with the new middle school at the proposed size of 164,771 square feet and estimated cost of \$61,361,823. County Manager Adam Stumb added that with the Board's approval, the County would need to begin holding financing meetings with the Local Government Commission. He also noted that while material prices are high, interest rates are low. Dr. Cox added that the school system had been awarded a \$15 million grant from the State that will be applied to the cost of the project. Commissioner Olive made a motion to commit to funding a new middle school in the amount of \$61,361,823. Vice Chairman Sands seconded the motion. The motion passed with unanimous approval.*
