Chairman McNeill called the Budget Work Session to order at 9:02 a.m. at the Ashe County Agricultural Services Building Conference Room. Commissioner Jordan left the meeting at approximately 11:15 a.m.

Finance Officer Sandra Long told the Board that a 3% COLA increase was included in the salaries for all employees.

County Manager Adam Stumb left the room. The Board decided to increase County Manager Stumb's annual salary by \$5,000 for the completion of a master's degree in May 2021, per the stated agreement between the Board and Mr. Stumb at the time of his appointment as County Manager. He will also receive the 3% COLA as stated in his contract.

Clerk to the Board Ashley Honeycutt left the room. The Board decided to reclassify Ms. Honeycutt to Grade 66 Administrative Assistant to the County Manager/Clerk to the Board once she completes the UNC School of Government's Clerks Certification Class.

Economic Development

The Board decided to reduce Computer Support by \$4,000, which will be applied to Human Services to benefit the Ashe County Farmers Market.

Chairman McNeill requested close oversight of the social media management to ensure effectiveness.

The Board removed \$7,000 from Advertising & Marketing to be placed in the contingency fund for promotion of the Industrial Park after the Park's development is complete.

Cultural Arts

The Board requested that the Ashe County Arts Council's allocation be combined with the allocation for the Civic Center. The combined FY 21-22 allocation for the aforementioned will be \$150,000 from occupancy tax revenues. Chairman McNeill noted that as a result, the Arts Council's and Civic Center's County allocations would be completely funded by occupancy tax and tourism, and that the reorganization would save \$35,000 from the General Fund.

The Board budgeted \$108,666 from occupancy tax revenues for the 1904 Courthouse Preservation Organization.

The Board added \$50,000 to Capital Outlay/Equipment to replace the motor in the 826H Compactor.

Discussion

The Board shared much discussion on the proposed tax rate. The proposed 6.7 cent increase was agreed upon by the Board, due to the following factors: the new middle school project, for which financing requires 4 additional cents of tax; increases in State retirement rates over the last two years, contributing an additional 0.6 cents; and other costs attributed to the 3% COLA, grade raise for Law Enforcement employees, increasing fuel prices, and significant increases in foster care, resulting in a combined 2 cents. The proposed total tax rate is 51 cents.

II. Adjournment

Vice Chairman Sands made a motion to adjourn the meeting at 1:43 p.m. Commissioner Powers seconded the motion. The motion passed with unanimous approval. **Approved** For: 4 - Commissioner Olive, Chairperson McNeill, Vice Chairman Sands and Commissioner Powers
