PRES 9:05 AM - Ashe Memorial Hospital CEO Brian Yates - Ashe Memorial

Ashe Memorial Hospital CEO Brian Yates presented to the Board a request for American Rescue Plan (ARP) funds for Ashe Memorial Hospital (AMH). Mr. Yates explained that the COVID-19 pandemic had taken a severe toll on personnel, causing many to exit employment and making efforts to retain and recruit employees difficult. He said that since March 11, 2020, AMH had 111 direct patient care staff members leave. He added that North Carolina ranks fourth highest in the nation for crisis nursing staff demand. Mr. Yates requested ARP funds to create recruitment and retention bonuses, allocated subject to a sub-recipient agreement with the County. The Board expressed agreement with the need to retain skilled local medical staff. County Manager Adam Stumb added that this ARP expenditure would be included in the amended budget presented later in the meeting (PRES 21-159).

SkyLine Chief Marketing and Sales Officer Edward Hinson, Chief Technology Officer Robbie Farmer, Outside Plant Engineering Manager Brantley Davis, and Strategic Sales Supervisor Brent Keith presented to the Board a request for American Rescue Plan (ARP) funds. Mr. Hinson shared with the Board a presentation detailing SkyLine's project for which the ARP funds are requested and which would extend fiber coverage to unserved or underserved areas in Ashe County. He noted that the total project cost is \$1.085 million and that SkyLine has already provided approximately \$250,000, so the request is for the remaining cost. Mr. Hinson and Mr. Farmer both highlighted difficulties with supply chains, noting that any delays could result in higher costs and longer timelines. Commissioner Olive requested that SkyLine meet with the Jefferson and West Jefferson town managers and County Manager Stumb to discuss the towns contributing to the project, as the majority of the underserved areas are within those towns.

County Manager Adam Stumb shared with the Board a proposed premium pay policy, amended as requested by the Board at the regular session meeting on October 18, 2021. He added that \$1,740 gross would provide most full-time employees with approximately \$1,500 after taxes and benefits. Commissioner Powers made a motion to approve the

policy as presented. Commissioner Jordan seconded the motion. The motion passed with unanimous approval.
